INFORMATION ON THE PROCESSING OF PERSONAL DATA FOR THE YCM COMPETITION PARTICIPANT

The data will be processed for the purpose of:

- a) conduct a competition, including the transfer of the prize to the winners and publication of the image of the participants (legal basis - the legitimate interest of the administrator - Article 6 (1) (f) of the GDPR),
- b) settlement of the prizes awarded to the winners (legal basis - fulfillment of the legal obligation incumbent on the administrator in the field of tax law - Article 6 (1) (c) of the GDPR);
- c) consideration of complaints (legal basis - legitimate interest of the administrator - art.6 par.1 lit.f RODO).
